Positive Target Market of End Investors

Colchester has assessed that the Fund meets the needs, characteristics and objectives of the following generic target market of end investors:

- Retail and professional clients and eligible counterparties. These investors may be categorised as follows:
 - o Basic Investors, including advised and non-advised retail investors.
 - o Informed Investors i.e. advised retail investors including:
 - Single and Multi-Family Offices,
 - Wealth Management/Wealth Advisory and
 - Independent Financial Advisors (IFAs)
 - o Advanced Investors (and Expert Investors in Germany), including:
 - Institutional investors (public and corporate pension funds, corporate treasuries, insurance companies)
 - Official institutions (sovereign wealth funds, central banks and other government/public bodies)
 - Endowments, Foundations & Charities (CFOs/Treasury Departments)
 - Intermediaries such as Private Banks, Fund-of-Funds, Multi-Managers (Fund Selectors)
- Investors with basic capital markets knowledge and/or experience about the characteristics and risks associated with investment funds, bonds and currencies.
- Investors with adequate financial resources such that they can bear up to 100% loss of capital invested.
- Investors who have a low to medium risk tolerance and are willing to accept price fluctuations in exchange for the opportunity of possible higher returns. Please refer to the Risk and Reward indicator in the relevant Key Investor Information Document for the Fund.
- Investors who seek income and capital growth and have a medium-to-long term investment horizon of 3 to 5 years.
- This strategy is suitable for investors with sustainability related objectives, who desire a strategy which promotes environmental characteristics through investing in Green Bonds, and which integrates sustainability risks into its investment decisions. Green Bonds are bonds issued by governments, supra-nationals, agencies and other types of issuers to fund projects that benefit the environment.

Negative Target Market of End Investors

Colchester has assessed that the Fund does not meet the needs, characteristics and objectives of the following generic target market of end investors:

- Investors who require capital preservation at all times.
- Investors who require full or partial capital protection and/or are seeking on-demand full repayment of the amounts invested.
- Investors that are fully risk averse, have no risk tolerance or no tolerance for price fluctuations.
- Investors with an investment horizon of less than 3 years, during which time the strategy may not have had time to reach its investment objective.

As the strategy's investment philosophy and approach are compatible with the above Positive Target Market of End Investors the product is eligible for all distribution channels that reach such Positive Target Markets.
